INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement dated September 11, 2007 is between SILICON VALLEY BANK ("Bank") and NOETIX CORPORATION ("Grantor").

RECITALS

A. Bank will make advances to Grantor ("Loans") as described in the Loan and Security Agreement of approximate date herewith (the "Loan Agreement"), subject to, among other things, Grantor granting to Bank a security interest in its Copyrights, Trademarks, Patents, and Mask Works (as each of such terms is defined on Schedule I attached hereto).

B. Grantor has granted Bank a security interest in all of its right, title and interest, presently existing or later acquired to all the Collateral.

AGREEMENT

1. Grantor grants Bank a security interest in all of its right, title and interest in its intellectual property collateral (such as the Copyrights, Patents, Trademarks and Mask Works, (as specifically listed on Schedules A, B, C, and D hereto), and all proceeds (such as license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements rights throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part.

2. This security interest is granted in conjunction with the security interest granted under the Loan Agreement. Bank's rights and remedies in the security interest are in addition to those in the Loan Agreement and the other Loan Documents, and those available in law or equity. Bank's rights, powers and interests are cumulative with every right, power or remedy provided here. Bank's exercise of its rights, powers or remedies in this Agreement, the Loan Agreement or any other Loan Document, does not preclude the simultaneous or later exercise of any or all other right, power or remedy.
