TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of September 4, 2007, by and between GOLDEN TIMES PUBLICATIONS, INC., a New York corporation ("Assignor") and GATEHOUSE MEDIA NEW YORK HOLDINGS, INC., a Delaware corporation ("Assignee").

Assignor covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment. Assignor hereby assigns to Assignee all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark. Assignor further agrees to: (a) execute, verify, acknowledge and deliver all such further papers as may be necessary to transfer to or maintain Assignee's ownership of the Trademark; and (b) perform such other acts as Assignee lawfully may request to obtain or maintain the Trademark.
