ASSIGNMENT

THIS ASSIGNMENT, to be effective as of December 19, 2002, is by and between TECHNOGUIDE AS ("TECHNOGUIDE"), a corporation organized under the laws of Norway, and SCHLUMBERGER LIMITED ("SL"), a corporation organized under the laws of the Netherlands Antilles.

WITNESSETH:

WHEREAS, TECHNOGUIDE entered into a Purchase Agreement dated December 19, 2002 by and among TECHNOGUIDE, hereinafter referred to as SELLER, SCHLUMBERGER INFORMATION TECHNOLOGY SERVICES NORGE AS, hereinafter referred to as ASSETS BUYER and SCHLUMBERGER LIMITED, hereinafter referred to as IP BUYER (the "Purchase Agreement");

WHEREAS, TECHNOGUIDE, is the owner of certain intellectual property rights relating to the software business as described on Schedule "A" attached hereto (the "IP Rights");


WHEREAS, pursuant to the Purchase Agreement, SELLER sold to IP BUYER its entire right, title and interest in and to the IP Rights;

WHEREAS, IP BUYER is desirous of acquiring or confirming its acquisition of the entire right, title and interest in and to the IP Rights;




