TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made as of August 8, 2007 (the "Effective Date") by and between Rodan & Fields, Inc., a Delaware corporation ("Assignor") and KPRKAR LLC, a California limited liability company ("Assignee") (referred to collectively as the "Parties" and individually as a "Party").

WHEREAS, Assignor, together with its affiliate, The Estée Lauder Companies Inc. ("ELC" and, together with Assignor, "Sellers") had been engaged, directly or indirectly, in the business of manufacturing, marketing, distributing and selling the skin care and related products currently sold by Sellers under the "Rodan + Fields" brand name (the "R+F Business");

WHEREAS, Assignor owns the trademark applications and registrations set forth in Exhibit A (the "Marks");

WHEREAS, Assignee, Sellers, among others, are parties to that certain Asset Purchase Agreement, dated as of even date herewith (the "Asset Purchase Agreement");

WHEREAS, pursuant to the Asset Purchase Agreement, Assignee purchased certain assets, including the Marks, from Sellers and Sellers assigned to Assignee, among other things, all of its right, title and interest in and to any and all of the Marks; and

WHEREAS, Assignor assigned the Marks to Assignee as part of the entire business or portion thereof to which the marks pertain as required by 15 U.S.C. § 1060.

NOW, THEREFORE, in consideration of the mutual agreements, provisions and covenants contained herein and in the Asset Purchase Agreement, the Parties agree as follows:

1. Assignor hereby transfers, conveys and assigns to Assignee all right, title and interest throughout the world in and to the Marks, together with (a) all common law rights related thereto; (b) all goodwill associated therewith, and (c) and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights in the Mark; and to settle and retain proceeds from any such actions) (collectively, the "Rights").

2. Notwithstanding anything to the contrary, this Assignment does not create, expand or restrict any representation or warranty regarding ownership of the Marks. Such representations or warranties are created, and only created, in the Asset Purchase Agreement.

3. Upon reasonable request by Assignee and subject to the conditions of the Asset Purchase Agreement, Assignor shall execute such written instruments, extend such other cooperation and perform such other acts as may be necessary or appropriate, in the opinion of Assignee, to convey, establish, evidence, maintain, defend and enforce Assignee's Rights in the Marks; and Assignor hereby irrevocably appoints Assignee and any of its officers as Assignor's attorney in fact to undertake such acts in Assignor's name.

4. All questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Agreement shall be governed by the laws of the State of New York, regardless of the laws that might otherwise govern under applicable principles of conflict of laws.

5. This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement.
