**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** is given as of this 28 day of September, 2007, by The CIT Group / Business Credit, Inc., a New York corporation (the "Secured Party").

**WHEREAS**, Gander Mountain Inc. (the "Grantor"), a Wisconsin corporation and predecessor-in-interest to Gander Mountain Company, a Minnesota corporation, pursuant to a Trademark Mortgage, dated August 12, 1996, granted to the Secured Party a security interest in the United States trademark applications and trademark registrations set forth on SCHEDULE A attached hereto ("the Marks") which Trademark Mortgage was recorded with the United States Patent and Trademark Office on October 16, 1996, at Reel 001488, Frame 0786 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under the Trademark Mortgage;

**WHEREAS**, Grantor has fully and completely discharged and satisfied its obligations to the Secured Party under the Trademark Mortgage; and

**WHEREAS**, the Secured Party has agreed to release its security interest in the Marks as herein provided.

**NOW, THEREFORE**, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases its security interest in the Marks set forth on SCHEDULE A hereto, and consents that the assignment of security interest by the Grantor in favor of the Secured Party be discharged and released of record in the U.S. Patent and Trademark Office with respect to the Marks set forth on SCHEDULE A hereto.
