TRADEMARK ASSIGNMENT

Assignor further authorizes the Commissioner of Trademarks of the United States Patent and Trademark Office to record the Trademark as the property of Assignee; and

Assignor further agrees to execute such further documents as may be required to record Assignee as the owner of the Trademark and registration therefor.
