Assignor agrees to execute and deliver, at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may require in order to vest, perfect and register all Assignor's right, title, and interest in and to the Marks in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent that such evidence is in the possession or control of Assignor. If Assignor does not within 15 days of presentment or request, return documents requested by the Assignee to be executed by the Assignor, then the Assignee is hereby granted a limited power of attorney to execute all such documents and perform all such acts on behalf of the Assignor. This power of attorney is coupled with an interest and is irrevocable.
