**TERMINATION OF
COPYRIGHT AND TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION OF COPYRIGHT AND TRADEMARK SECURITY AGREEMENT (this "Agreement") is entered into as of this 1st day of October, 2007, by M&I MARSHALL & ILSLEY BANK, a Wisconsin state banking corporation (the "Secured Party"), in favor of GELCO INFORMATION NETWORK, INC., a Minnesota corporation (the "Debtor").

WHEREAS, the Debtor and the Secured Party are parties to that certain Credit and Security Agreement dated as of December 21, 2006, as amended (the "Credit Agreement"); and

WHEREAS, as a condition to making such loans and other financial accommodations under the Credit Agreement, the Debtor entered into that certain Copyright and Trademark Security Agreement dated as of December 21, 2006 between the Debtor and the Secured Party (the "Intellectual Property Security Agreement") further evidencing the grant by the Debtor to the Secured Party of a security interest in the Copyrights and Trademarks (each as defined therein), which Intellectual Property Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on February 20, 2007 at Reel 3484, Frame 0153; and



WHEREAS, the Credit Agreement has been terminated and all amounts owing under the Credit Agreement have been paid in full; and

WHEREAS, the Debtor has requested that the Secured Party enter into this Agreement to terminate its security interest pursuant to the Intellectual Property Security Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates its security interest in the Copyrights and Trademarks as more particularly described on the attached Exhibits A and B, and hereby terminates and cancels the Intellectual Property Security Agreement.
