## NOTICE OF SECURITY INTEREST IN TRADEMARKS

- C. The Borrowers have granted to the Lender a security interest in the Trademarks and the goodwill of the Borrowers' businesses connected with and symbolized by the Trademarks on the terms and conditions set forth in the Security Agreement;
- D. Pursuant to the Security Agreement, the Borrowers have granted to the Lender a security interest in and to all of the Trademarks, service marks, applications therefore and associated goodwill therein, now owned or from time to time after the date hereof owned or acquired by either or both of the Borrowers, including, without limitation, the Trademarks, and in and to all proceeds and benefits thereof;
- E. There are no liens or security interests on the Trademarks other than the interests of the Lender; and
- F. Capitalized terms not defined herein shall have their meaning as set forth in the Security Agreement.
