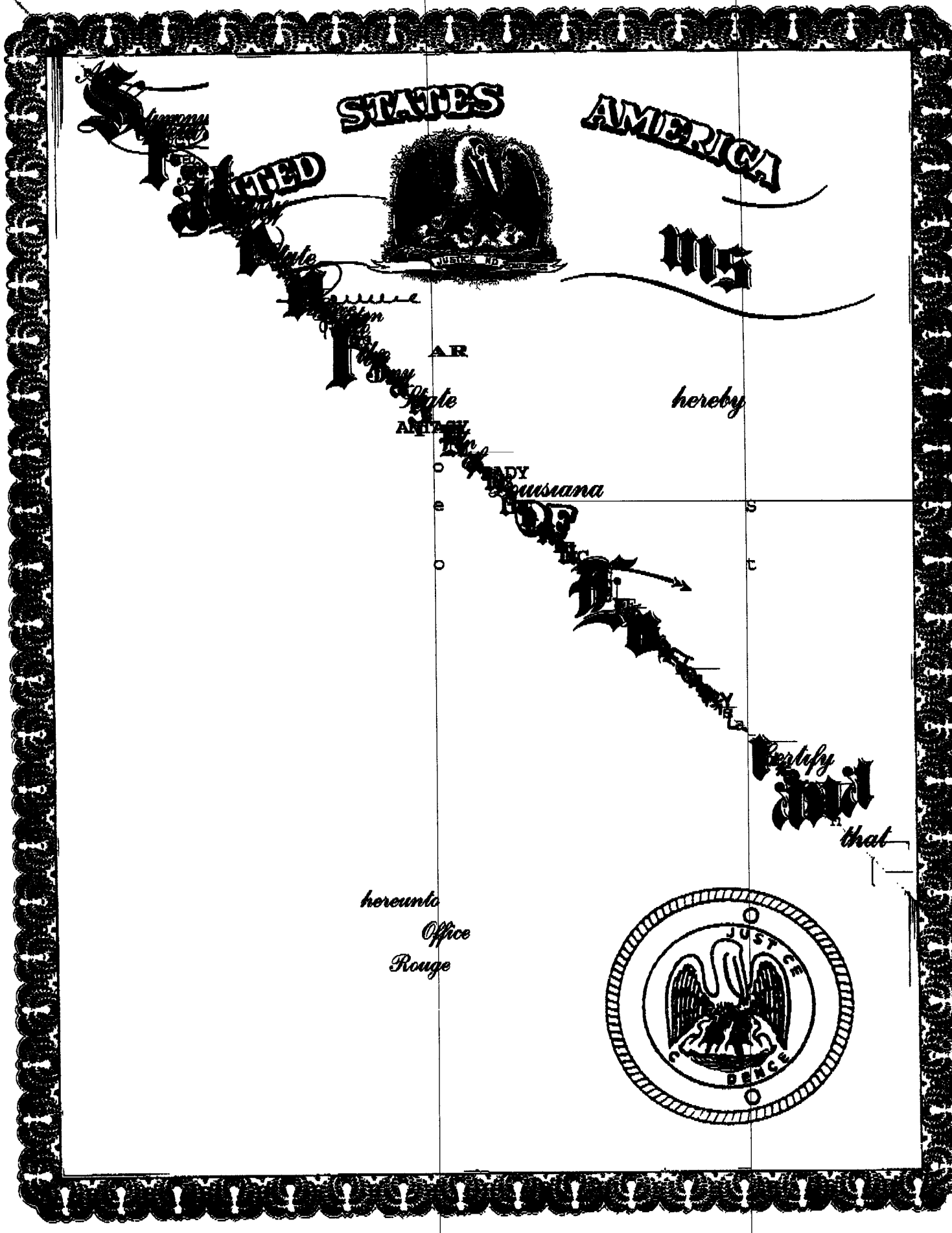

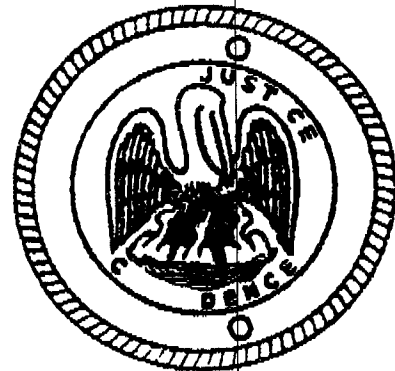

All business and managerial function shall be performed by the founding member of the original company stated herein. Only the name is being changed.


