TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") dated as of September 21, 2007, is by and between Virgo Publishing, LLC, a Delaware limited liability company (the "Assignee") and TeleStrategies, Inc. a Virginia corporation (the "Assignor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, pursuant to the Agreement, the Assignor hereby irrevocably conveys, sells, assigns and transfers to the Assignee, its successors and assigns, all worldwide right, title and interest, legal and equitable, in and to the Trademarks, together with all of the goodwill of the business symbolized by the Trademarks, including the goodwill of that portion of the Assignor's business for which it has a bona fide intent to use the Trademarks. The assignment of the Trademarks granted herein includes all rights of action accrued, accruing and to accrue under and by virtue of the Trademarks, including all right to sue or otherwise recover for past, present and future infringement and to receive all damages, payments, costs and fees associated therewith. The Assignor shall, at its own cost and expense, execute and deliver any and all instruments and documents and take such further actions as may be necessary or reasonably requested by the Assignee to document and record with the appropriate authorities the aforesaid assignment and transfer, provided that the Assignee shall be solely responsible for filing and recording such documents.

This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which, taken together, shall constitute one and the same assignment. Delivery of an executed counterpart of a signature page to this Assignment by facsimile shall be effective as delivery of a manually executed counterpart hereof.


