**REQUEST FOR CORRECTION OF IMPROPERLY RECORDED ASSIGNMENT AND
SECURITY INTEREST PURSUANT TO §503.06(C) OF THE TRADEMARK MANUAL
OF EXAMINATION PROCEDURES**

Dino-Store, Inc. (Dino-Store), current owner and assignee of the trademark DINOSAUR (Mark) and Registration No. 2,931,125 (Registration) having an Application Serial No. 76/299240 (Application), hereby requests correction of the assignment history pursuant to §503.06(c) of the Trademark Manual of Examination Procedures. Dino-Store, in compliance with §503.06(c), submits:

- A completed cover sheet identifying the Registration against which an assignment and a security interest were improperly recorded;
- This declaration summarizing below the true chain of title to make clear that the chain of title for the Registration identified should not be considered altered by the incorrect assignment and security interest, and that Dino-Store has been and continues to be the owner of the Registration; and
- The recording fee of \$40.00 pursuant to 37 C.F.R. 2.6(b)(7).

Dino-Store confirms that it has been and continues to be the owner of the Mark and Registration as the Mark and Application were voluntarily assigned to Dino-Store from Heluva Good LLC on May 8, 2002 and recorded on June 5, 2002, under Reel/Frame: 2524/0581. The Security Interest, recorded under Reel/Frame: 2857/0171, and the Assignment, recorded under Reel/Frame: 3001/0915, were both executed and recorded after the assignment from Heluva Good LLC to Dino-Store, without Dino-Store's knowledge or consent. Accordingly, the Security Interest and Assignment were both improperly recorded against the Application and resulting Registration. Dino-Store has put both parties on notice of the erroneous recordings, however, neither party has acted to correct the respective errors.

Dino-Store understands that this is a correctable error as provided by §506.03(c) of the Trademark Manual of Examination Procedures.

The Commissioner for Trademarks is authorized to charge the required official fee of \$40 to Deposit Account No. 50-3010.
