
1. Applicant, Video Plus, L.P. is the correct owner of the above referenced mark.
2. On June 12, 2001, Video Plus, Inc. filed a trademark application for the above referenced mark.
3. On January 3, 2005, Video Plus, Inc. converted from a Delaware corporation to a Texas Limited Partnership under the name Video Plus, L.P. This conversion was recorded with the USPTO on June 7, 2006 at Reel/Frame: 3322/0726.

4. On October 15, 2007, an erroneous assignment was recorded at Reel/Frame: 3640/0235 ("Assignment"). The Assignment is erroneous because the owner is misidentified. The Assignment states that Video Plus, Inc. is the owner of the mark identified in the above referenced Application. But, Video Plus, L.P. is the actual owner. The Assignment is also erroneous because it incorrectly identifies the trademark application that is the subject of the Assignment. The Assignment assigns R&L Publishing, Ltd. rights in the mark "WELLNESS REVOLUTION" in International Class 16 and as reflected in U.S. Serial No. 76/270,448. However, the assignment was intended to assign rights in the mark "WELLNESS REVOLUTION" in International Class 9 and as reflected in U.S. Registration No. 3,280,360.

5. Applicant, Video Plus, L.P., respectfully requests that the Office accept Applicant's request to correct the error of ownership as reflected in the Assignment that was filed on October 15, 2007 at Reel/Frame: 003640/0235.

6. Applicant submits the fee per class as required by Section 2.6.
