## TRADEMARK ASSIGNMENT

3. ASSIGNEE shall retain the exclusive right to bring and maintain actions for, and to settle, release and compromise claims for infringement of, the Trademarks occurring prior to the date hereof and to retain the proceeds thereof.

4. Except as otherwise expressly provided herein, no obligation is hereby assumed by ASSIGNOR to maintain, prosecute, enforce, litigate concerning, assert or defend the Trademarks or to file any document with respect thereto.
