RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of October 18, 2007 (“Effective Date”) by and between **Lehman Commercial Paper, Inc.** (as Administrative Agent), a Delaware corporation, with an office at 745 Seventh Avenue, New York, New York 10019, (“Grantee”), on the one hand, and **CBD Media LLC**, a Delaware limited liability company, with an office at 312 Plum Street, Suite 900, Cincinnati, Ohio 45202, **CBD Media Holdings LLC**, and **CBD Finance, Inc.** (collectively, “Grantors”), on the other.

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and Grantee dated June 13, 2003 (the “Trademark Security Agreement”), Grantors granted to Grantee a continuing security interest in and to all of Grantors’ right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantors (collectively, the “Trademarks”), and certain trademark licenses to which Grantor was party (the “Trademark Licenses”), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto and the Trademark Licenses set forth on Schedule B attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantors and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantors and Grantee dated June 13, 2003 (the “Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on June 13, 2003, at Reel 2757, Frame 0904; and

WHEREAS, Grantors have paid all of their outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks and the Trademark Licenses.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release and (ii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, or any trademark license in any jurisdiction throughout the world, other than (x) those Trademarks set forth on Schedule A (attached hereto) and those Trademark Licenses set forth on Schedule B (attached hereto), and (y) state filings to evidence the security interest granted pursuant to the Security Agreement

Grantee shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantors to more fully and effectively effectuate the purposes of this Release.
