ASSIGNMENT OF TRADEMARKS

ASSIGNMENT OF TRADEMARKS, dated as of October 4, 2007 (this "Assignment"), is made by L.C. LICENSING, INC., a Delaware corporation ("Assignor"), having an address at 1441 Broadway, New York, New York 10018, in favor of THE MILLWORK TRADING CO., LTD. d/b/a LI & FUNG USA, a Delaware corporation ("Assignee"), having an address at 1359 Broadway, 21st Floor, New York, New York 10018. Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Purchase Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Assignor owns all right, title and interest in and to the trademarks and service marks listed on the attached Schedule A, all applications and registrations pertaining thereto, all common law rights associated therewith, together with all goodwill arising from use of and symbolized by said trademarks (the "Trademarks").

WHEREAS, Assignee, has entered into an Asset Purchase Agreement with Assignor, dated as of September 13, 2007, as amended by the letter amendment dated as of October 4, 2007 (the "Purchase Agreement"), and incorporated herein by reference, pursuant to which Assignee has purchased certain assets from Assignor, including the Trademarks listed on Schedule A attached hereto, on the terms and conditions contained therein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor does hereby assign, sell, transfer and convey to Assignee, its successors and assigns, all of Assignor's right, title and interest, in and to the Trademarks throughout the world, including all trademark applications and registrations therefor, any common law rights to such Trademarks, all goodwill of the business symbolized by the Trademarks, the portion of the business of Assignor to which any intent-to-use applications pertain, as well as the right to sue and to collect all damages and payments for claims of past and present infringement or misappropriation thereof.

2. Assignor hereby agrees to execute upon the request of Assignee such additional instruments, documents and papers as are necessary to continue, secure, defend, register and otherwise give full effect to and to perfect the rights of Assignee under this Assignment in and to the Trademarks worldwide, including all documents necessary to register in the name of Assignee the assignment of Trademarks with the US Patent & Trademark Office, and with respect to any equivalent foreign rights, with any other appropriate trademark office or registrar.

3. Notwithstanding any other provision of this Assignment to the contrary, nothing contained herein shall in any way supersede, amend, rescind, waive, expand, or in any other way affect the provisions, including the representations, warranties, covenants and agreements or the rights and remedies of any of the parties under the Purchase Agreement. This Assignment is intended only to effect the transfer of the Trademarks, pursuant to the Purchase Agreement, and shall be governed entirely in accordance with the terms and conditions of the Purchase Agreement.

4. This Assignment shall be governed by, and construed and enforced in accordance with, the laws of the State of New York.
