**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST (this "Release") dated as of September 26, 2007, from KIMCO CAPITAL CORP., a Delaware corporation ("KIMCO") to GOTTSCHALKS INC., a Delaware corporation (the "Company"), located at 7 River Park Place East, Fresno, California 93720.

WITNESSETH:

WHEREAS, pursuant to a security agreement dated as of March 22, 2002, in favor of KIMCO (the "Security Agreement"), a security interest was granted by the Company to KIMCO in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 9, 2002, at Reel 2482 and Frame 0656; and

WHEREAS, KIMCO now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;


NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, KIMCO hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Company's right, title and interest of every kind and nature as of the date hereof in the trademarks and related collateral described in the Security Agreement, including, without limitation, those U.S. trademark registrations listed on Schedule A hereto.

2. Release of Security Interest. KIMCO hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of KIMCO in such Trademark Collateral shall hereby cease and become void.
