From: CIBC WORLD MARKETS PLC (the "**Security Agent**"), acting on behalf of each of the Secured Parties (as defined below).

To: COPERION CORPORATION (f/k/a Krupp Werner & Pfleiderer Corporation) (the "**Company**").

Recitals

- (A) Pursuant to a pledge and security agreement over Krupp Werner & Pfleiderer Corporation's assets dated December 21, 2000 (as amended on June 27, 2001, the "**Security Agreement**") between the Company and the Security Agent, on behalf of the secured parties identified therein (the "**Secured Parties**"), which was recorded in the U.S. Patent and Trademark Office (the "**USPTO**") on June 29, 2001, at Reel 2327, Frame 0417, the Company has granted a security interest in its right, title and interest in and to the marks listed in Schedule 1 (*Trademarks*) (the "**Trademarks**") to the Security Agent, on behalf of the Secured Parties.
- (B) In connection with the global release of security agreement dated March 6, 2007, relating to the repayment in full of obligations owed under a facilities agreement dated December 19, 2000 (and as amended thereafter) between, *inter alia*, the Company and the Security Agent (acting on behalf of the Secured Parties), the Secured Parties have agreed to release the security interests created under the Security Agreement on the terms and conditions set forth therein.


- 1.1 The Security Agent hereby releases the security interests over the Trademarks created by the Security Agreement.


