**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**


WHEREAS, Authoria, Inc., a Delaware corporation, whose address is 300 Fifth Avenue, Waltham, Massachusetts 02451 (the "Company"), and Silicon Valley Bank dba Silicon Valley East, a California chartered bank, whose address is 3003 Tasman Drive, Santa Clara, California 95054 (the "Bank"), entered into a certain Intellectual Property Security Agreement (the "Security Agreement"), dated as of July 28, 2004, which was recorded in the United States Patent and Trademark Office on August 17, 2004 at Reel 2927 and Frame 0869, that by its terms granted the Bank a security interest in any trademark and service mark rights, slogans, trade dress, and tradenames, trade styles, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of the Company connected with and symbolized by such trademarks, including, without limitation, those owned by the Company listed in Schedule A (the "Trademarks"); and

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Trademarks was granted.

NOW THEREFORE the parties hereto agree that the Bank hereby reassigns to the Company its interest in the Trademarks in which the Bank was granted a security interest under the Security Agreement. The Bank also hereby releases its security interest in the Trademarks. The Bank, further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Company, to effectuate this termination.


