ASSIGNMENT AGREEMENT

U.S. Trademark Registration No. 2,519,244 "TOMADOL"


U.S. Trademark Registration No. 1,607,906 "TOMAH"

together with the goodwill of the business associated with said trademarks, effective as of the date set forth herein.


