Trade-Mark Assignment

NOW, THEREFORE, the Assignor declares as follows:

1. The Assignor, for and on behalf of Tiger Brand, hereby unconditionally assigns and transfers to the Assignee, without warranty as to the registrability or validity thereof, in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Tiger Brand' entire right, title and interest in and to the Trade-marks in Canada and the United States, and the goodwill attached to the Trade-marks.
2. The assignment shall be binding upon the parties, their successors and permitted assigns.
3. The Assignor undertakes and agrees to execute, at the request and expense of the Assignee, such further assurances as may be reasonably required in order to permit the Assignee to obtain recording of this agreement.
