TRADEMARK RELEASE, effective as of this 28th day of March, 2007, given by Deutsche Bank Trust Company Americas, as Collateral Agent ("Agent") with principal offices at 60 Wall Street, New York, NY 10005, to Consolidated Container Company LP, a Delaware limited partnership ("Grantor"), with principal offices at 3101 Towercreek Parkway, Suite 300, Atlanta, GA 30339, as follows:


