This Acknowledgment is being delivered by U.S. Bank National Association (the "*Trustee*"), as successor trustee to Firststar Bank, N.A. under that certain Indenture, dated as of August 22, 2001 (the "*Indenture*"), among Progressive Gaming International Corporation, a Nevada corporation (the "*Company*"), each of the Guarantors thereto, and the Trustee with respect to the Company's 11.875% Senior Secured Notes due 2008.

Reference is made to the Purchase Agreement (the "*Purchase Agreement*") dated as of September 25, 2007, by and among Company, certain of its affiliates and subsidiaries (the Company such affiliates and subsidiaries being referred to herein as the "*Seller*"), and Shuffle Master, Inc. and each of its affiliates and subsidiaries (collectively, the "*Buyer*"), a copy of which is attached hereto as Exhibit A. Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Purchase Agreement or the Indenture.

Pursuant to (i) the Purchase Agreement the Seller will sell, transfer, assign, or otherwise dispose of certain Purchased Assets to Buyer and (ii) in connection therewith the Seller and Buyer will enter into an Amended and Restated License Agreement dated as of September 25, 2007 (the "*License Agreement*") pursuant to which the Seller will license on an exclusive basis certain rights of Seller in the Licensed Patents to Buyer (the "*Licensed Patent Rights*") (collectively, the transactions in (i) and (ii) being referred to herein as the "*Asset Sale*"). Pursuant to Section 10.4 of the Indenture, the Trustee hereby releases its Liens on the Purchased Assets and the Licensed Patent Rights and acknowledges that all Liens on the Purchased Assets and the Licensed Patent Rights are free of the security interest of the Indenture and any Collateral Agreements. The Trustee hereby authorizes the filing of UCC-3 amendment statements in the form attached hereto as Exhibit B to evidence the foregoing release. In addition, the Trustee, as promptly as practicable, shall execute and deliver to the Company such documents or instruments, in form and substance satisfactory to the Company, as the Company or the Buyer shall reasonably request, in form suitable for filing to evidence the foregoing release



**RELEASE OF SECURITY AGREEMENT
IN TRADEMARK COLLATERAL**
