TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement"), is made and entered into as of August 17, 2007 between Ozark Mountain Pork Cooperative, a Missouri cooperative ("OMP") and Heritage Acres Foods, LLC, a Missouri limited liability company ("HAF").

WHEREAS, OMP is the owner of the trademarks identified on the attached Schedule A (the "Trademarks");

WHEREAS, OMP and HAF have executed an Intellectual Property Purchase Agreement dated as of the date hereof (the "Purchase Agreement");

WHEREAS, OMP desires to transfer and assign its rights in the Trademarks to HAF pursuant to the terms of the Purchase Agreement, and HAF desires to accept such transfer and assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Subject to the terms and conditions of the Purchase Agreement and effective as of the Closing Date (as defined in the Purchase Agreement), OMP hereby sells, transfers, assigns and conveys to HAF, and HAF hereby accepts from OMP, all of OMP's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby and the registrations identified on Schedule A.

2. Miscellaneous. This Agreement shall be governed by and construed in accordance with the laws of the State of Missouri, without regard to conflicts of law principles, and may be executed in counterparts, all of which shall be considered one and the same instrument, and shall become effective when counterparts have been signed by each party and delivered to the other party.

IN WITNESS WHEREOF, OMP and HAF have made this Agreement on and as of the date first above written.
