WITNESSETH:



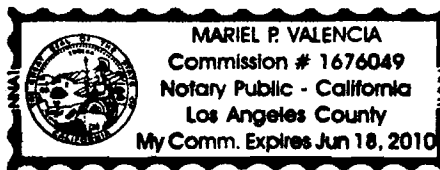
