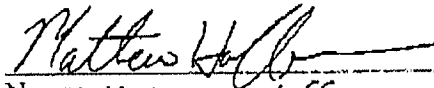

WHEREAS, PLVTZ, LLC (the "LLC") and PLVTZ, Inc. (the "Corporation," or collectively with the LLC, the "Petitioners") filed the above-captioned action on September 24, 2007 seeking equitable relief from this Court to remedy the inadvertent failure to file the Certificate of Conversion From a Limited Liability Company to a Corporation pursuant to Section 265 of the Delaware General Corporation Law (the "Certificate of Conversion");

WHEREAS, the Court has considered the Petition, and found that good cause has been show for the granting the equitable relief requested therein; and

WHEREAS, no member of the LLC or stockholder of the Corporation will be adversely affected by this order,

NOW, THEREFORE, IT IS HEREBY ORDERED THIS \_\_ day of September, 2007 that:

1. The Secretary of State of the State of Delaware is hereby ordered to accept the filing of the Certificate of Conversion dated as of the date that it is actually filed, but effective for all purposes as of July 6, 2007, at the time that the original Certificate of Incorporation of PLVTZ, Inc., a Delaware corporation, was filed with the Delaware Secretary of State.
2. The Certificate of Conversion shall contain a provision stating that it was filed with retroactive effect pursuant to this Order, and with a copy of this Order attached thereto.
3. Once filed and accepted by the Secretary of State, the Certificate of Conversion is and shall forever be deemed effective as of July 6, 2007, at the time that the original

Certificate of Incorporation of PLVTZ, Inc. was filed, with the effects set forth in 8 *Del. C.* § 265 and 6 *Del. C.* § 18-216, as of such date and time.
