**GRANT OF  
SECURITY INTEREST IN TRADEMARKS**

This GRANT OF SECURITY INTEREST IN TRADEMARKS ("Agreement"), effective as of August 16, 2007 is made by each of the signatories hereto (the "Grantors"), in favor of LEHMAN COMMERCIAL PAPER INC., as Collateral Agent (in such capacity, the "Collateral Agent") for the several banks and other financial institutions or entities (the "First Lien Lenders"), parties to the First Lien Credit Agreement, dated as of August 16, 2007 (as amended, supplemented or otherwise modified from time to time, the "First Lien Credit Agreement") among Velo Holdings Inc., a Delaware corporation ("Holdings"), Velo Acquisition Inc., a Delaware corporation (the "Initial Borrower"), Vertrue Incorporated, a Delaware corporation (the "Surviving Borrower"), the First Lien Lenders, Lehman Commercial Paper Inc., as Administrative Agent (in such capacity, the "Administrative Agent"), the Collateral Agent, JPMorgan Chase Bank, N.A., as Syndication Agent and Lehman Brothers Inc. and J.P. Morgan Securities Inc., as Joint Lead Arrangers.

W I T N E S S E T H:

WHEREAS, pursuant to the First Lien Credit Agreement, the First Lien Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrower is a member of an affiliated group of companies that includes each other Grantor;

WHEREAS, the proceeds of the extensions of credit under the First Lien Credit Agreement will be used in part to enable the Borrower to make valuable transfers to one or more of the other Grantors in connection with the operation of their respective businesses;

WHEREAS, the Borrower and the other Grantors are engaged in related businesses, and each Grantor will derive substantial direct and indirect benefit from the making of the extensions of credit under the First Lien Credit Agreement; and

WHEREAS, it is a condition precedent to the obligation of the First Lien Lenders to make their respective extensions of credit to the Borrower under the First Lien Credit Agreement that the Grantors shall have executed and delivered a First Lien Guarantee and Collateral Agreement, dated as of August 16, 2007, in favor of the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "First Lien Guarantee and Collateral Agreement") to the Collateral Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Administrative Agent, the Collateral Agent and the First Lien Lenders to enter into the First Lien Credit Agreement and to induce the First Lien Lenders to make their respective extensions of credit to the Borrower thereunder, each Grantor hereby agrees with the Collateral Agent, for the ratable benefit of the Collateral Agent and the First Lien Secured Parties, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the First Lien Credit Agreement and the First Lien Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest. Each Grantor hereby grants a continuing security interest in, and a right of setoff against, and agrees to assign, transfer and convey, upon demand made upon the occurrence and during the continuance of an Event of Default in accordance with the terms of the First Lien Guarantee and Collateral Agreement, without requiring further action by either party and to be effective upon such demand, all of such Grantor's right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Schedule A hereto) (collectively, the "Collateral"), to the Collateral Agent for the benefit of the Collateral Agent and the First Lien Lenders to secure payment, performance and observance of the Borrower Obligations.


SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the First Lien Lenders in connection with the First Lien Guarantee and Collateral Agreement and is expressly subject to the terms and conditions thereof. The First Lien Guarantee and Collateral Agreement (and all rights and remedies of the First Lien Lenders thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the First Lien Lenders with respect to the security interest in the Collateral granted hereby are more fully set forth in the First Lien Credit Agreement and the First Lien Guarantee and Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the First Lien Guarantee and Collateral Agreement, the terms of the First Lien Guarantee and Collateral Agreement shall govern.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

**GRANT OF  
SECURITY INTEREST IN TRADEMARKS**

This GRANT OF SECURITY INTEREST IN TRADEMARKS ("Agreement"), effective as of August 16, 2007 is made by each of the signatories hereto (the "Grantors"), in favor of LEHMAN COMMERCIAL PAPER INC., as Collateral Agent (in such capacity, the "Collateral Agent") for the several banks and other financial institutions or entities (the "Second Lien Lenders"), parties to the Second Lien Credit Agreement, dated as of August 16, 2007 (as amended, supplemented or otherwise modified from time to time, the "Second Lien Credit Agreement") among Velo Holdings Inc., a Delaware corporation ("Holdings"), Velo Acquisition Inc., a Delaware corporation (the "Initial Borrower"), Vertrue Incorporated, a Delaware corporation (the "Surviving Borrower"), the Second Lien Lenders, Lehman Commercial Paper Inc., as Administrative Agent (in such capacity, the "Administrative Agent"), the Collateral Agent, JPMorgan Chase Bank, N.A., as Syndication Agent and Lehman Brothers Inc. and J.P. Morgan Securities Inc., as Joint Lead Arrangers.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Second Lien Credit Agreement, the Second Lien Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrower is a member of an affiliated group of companies that includes each other Grantor;

WHEREAS, the proceeds of the extensions of credit under the Second Lien Credit Agreement will be used in part to enable the Borrower to make valuable transfers to one or more of the other Grantors in connection with the operation of their respective businesses;

SECTION 2. Grant of Security Interest.
