TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is effective as of June 30, 2004 ("Effective Date") by Chi Hsin Impex, Inc., a California corporation with a principal place of business at 14777 Don Julian Road, City of Industry, California 91746 ("Assignor") and The Nautilus Group, Inc., a Washington corporation with a principal place of business at 1400 N.E. 136th Ave., Vancouver, Washington 98684 ("Assignee"), pursuant to the terms of the Confidential Settlement Agreement and Release dated and effective June 30, 2004 ("Agreement"), between Assignor and Assignee.

RECITALS

A. B. Assignee wishes to acquire all rights Assignor may have in and to the Trademarks, together with the goodwill of the business associated therewith, along with the right to recover for damages and profits for past infringements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee, its successors, assigns, and legal representatives, all right, title, and interest in and to the Trademarks together with the goodwill associated therewith, and the right to recover damages and profits and all other remedies for past infringements thereof.


