## TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of October 26, 2007, is made by Partners for Growth, L.P., whose address is 180 Pacific Avenue, San Francisco, CA 94111 (the "Secured Party").

**WHEREAS**, Interwave Communications, Inc., Interwave Advanced Communications, Inc. and Interwave Communications International Ltd. 3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any Patent.

B.     Trademarks:

1. all of the Grantors' trademarks and trademark applications to which any Grantor is a party including those referred to on Schedule B attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantors against third parties for past, present or future (i) infringement or dilution of any trademark or (ii) injury to the goodwill associated with any trademark.
