RELEASE OF SECURITY INTEREST (TRADEMARKS)


THIS RELEASE OF SECURITY INTEREST (TRADEMARKS) (the "Release") is dated as of June 18 2007 by Bank of Scotland - Zweigniederlassung Frankfurt in its capacity as Security Agent for the Finance Parties (as that term is defined in the Senior Facilities Agreement dated October 26, 2006 among Mauser AG, certain subsidiaries of Mauser AG and Bank of Scotland - Zweigniederlassung Frankfurt and the other lenders party thereto) (the "Security Agent").

Pursuant to that certain Amended and Restated Intellectual Property Security Agreement dated as of November 9, 2005 among Mauser Corp. and National Container Group, LLC as grantors (collectively the "Debtors") and the Security Agent (the "Trademark Security Agreement"), the Debtors granted a security interest to the Security Agent in certain trademarks to secure the obligations described in the Trademark Security Agreement. The Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 10, 2005 on Reel/Frame 3192/523.

At the request of the Debtors, the Security Agent has agreed to release its security interests in the Trademarks described on Schedule I and, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Security Agent hereby releases and relinquishes any security interest in the Trademarks described on Schedule I of this Release.
