
WHEREAS, Assignor wishes to assign its right, title and interest in and to such Trademark to Assignee, its wholly-owned subsidiary.

Assignor further covenants with Assignee to execute, when requested, such additional assignments, instruments and documents as may be necessary or desirable to effectuate this Assignment.
