**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK**

THIS TERMINATION AND RELEASE is made as of this 14 day of October, 2007 by BANK OF SCOTLAND PLC (formerly named The Governor and Company of the Bank of Scotland), 123 St. Vincent Street, Glasgow, Scotland, UK G2 5EA (the "Lender").
