RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE, dated as of August 7, 2007, (the "Release") is made by BEAR STEARNS CORPORATE LENDING INC., as Administrative Agent ("Bear Stearns"), in favor of VICTORY ENVELOPE, INC., a Minnesota corporation (the "Pledgor"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to the First Lien Security Agreement between Pledgor and Bear Stearns dated as of November 3, 2006 (the "Security Agreement"), the First Lien Trademark Security Agreement between Victory Envelope, Inc. and Bear Stearns dated as of November 3, 2006 (the "Trademark Security Agreement"), Pledgor pledged and granted to Bear Stearns, for the benefit of the Secured Parties (as defined in the Security Agreement) a lien on and security interest in and to all of its right, title and interest in, to and under all the Trademarks (as defined in the Trademark Security Agreement and including, without limitation, the trademarks on Schedule A attached hereto); all Goodwill associated with such Trademarks; and all Proceeds of any and all of the foregoing (other than Excluded Property). Capitalized terms used herein without definition are used as defined in the Security Agreement and the Trademark Security Agreement;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 6, 2006 at Reel/Frame No. 003421/0954;

WHEREAS, the Pledgor has requested that Bear Stearns release its security interest in and to the Trademarks;

WHEREAS, Bear Stearns now desires to release, terminate and discharge the entirety of its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Credit Agreement, the Security Agreement and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, Bear Stearns hereby states as follows:


SECTION 1. Release of Security Interest. Bear Stearns, without recourse, representation or warranty, hereby TERMINATES, RELEASES and DISCHARGES its security interest in the Trademarks, and any right, title or interest of Bear Stearns in such Trademarks shall hereby cease and become void.

SECTION 2. Further Assurances. Bear Stearns shall execute and deliver to Pledgor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), shall provide Pledgor with any information and additional authorization necessary, and shall take all other actions necessary or reasonably desirable for the release of such Security Interest.


