RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of November / / , 2007 ("Effective Date") by and between **Bank of America, N.A.** (formerly known as **Fleet Capital Corporation**), a Delaware corporation, with its principal office at **Bank of America Corporate Center, Charlotte North Carolina** ("Grantee"), and **Foodhandler, Inc.** (formerly known as **Island Polyethylene Bag & Supply Corp.**), a New York corporation, with its principal office at 2301 Robb Drive, Reno, Nevada 89523 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Grantee dated October 27, 1999 (the "IP Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the following (all of which are hereinafter referred to collectively as the "Intellectual Property Collateral"): (a) any and all copyright rights, copyright applications, copyright registrations, and like protections in each work or authorship and derivative work thereof that was created by Assignor, whether published or unpublished, and whether or not the same also constitutes a trade secret, then or thereafter existing, created, acquired or held, including without limitation, those set forth on Schedule A attached hereto (collectively, the "Copyrights"); (b) any and all trade secrets, and any and all intellectual property rights in computer software and computer software products then or thereafter existing, created, acquired or held; (c) any and all design rights which may be available to Assignor then or thereafter existing, created, acquired or held; (d) all patents, patent applications and like protections, including without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation, the patents and patent applications set forth on Schedule B attached hereto (collectively, the "Patents"); (e) any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation, those set forth on Schedule C attached hereto (collectively, the "Trademarks"); (f) the right to the proceeds arising from any and all claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue on behalf of and collect such damages for said use or infringement of the intellectual property rights identified above; (g) all licenses or other rights to use any of the Copyrights, Patents or Trademarks, and all license fees and royalties arising from such use to the extent permitted by such license or rights; (h) all amendments, renewals and extensions of any of the Copyrights, Trademarks or Patents; and (j) all proceeds and products of the foregoing, including without limitation, all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing;

WHEREAS, Grantor and Grantee entered into the IP Security Agreement pursuant to the terms and conditions of that certain Loan and Security Agreement by and between Grantor, Grantee, and other "Borrowers" from time to time party thereto, dated October 27, 1999 (the "Loan Agreement");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on November 12, 1999, at Reel/Frame 1991/0241, with

respect to trademarks, and on November 12, 1999, at Reel/Frame 010388/0147, with respect to patents; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the IP Security Agreement and the Loan Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.


