THIS DEED OF RELEASE OF SECURITY is made on

4 September

2007

**BETWEEN:**

- (1) **THE GOVERNOR AND COMPANY OF THE BANK OF SCOTLAND** in its capacities (1) as security trustee for the Security Beneficiaries (as defined in the UK Security Documents) (the "Security Trustee"), (2) as senior collateral agent for the Senior Finance Parties (as defined in the Senior Collateral Documents) (the "Senior Collateral Agent") and (3) as subordinated collateral agent for the Subordinated Finance Parties (as defined in the Subordinated Collateral Documents) (the "Subordinated Collateral Agent") (the "Security Agent");
- (2) **THE GOVERNOR AND COMPANY OF THE BANK OF SCOTLAND** ("BoS"); and
- (3) **THE COMPANIES LISTED IN SCHEDULE 1** (the "Released Companies").

**WHEREAS:**

- (A) Certain of the Released Companies have executed in favour of the Security Trustee and BoS (as applicable) and are presently bound by certain documents made between, inter alia, (1) the Released Companies and (2) the Security Trustee or BoS (as applicable) and listed in part 1 of schedule 2 (*The Security Documents*) (together, the "UK Security Documents");
- (B) Certain of the Released Companies have executed in favour of the Senior Collateral Agent and are presently bound by certain documents made between, inter alia, (1) the Released Companies and (2) the Senior Collateral Agent and listed in part 2 of schedule 2 (*The Security Documents*) (together, the "Senior Collateral Documents");
- (C) Certain of the Released Companies have executed in favour of the Subordinated Collateral Agent and are presently bound by certain documents made between, inter alia, (1) the Released Companies and (2) the Subordinated Collateral Agent and listed in part 3 of schedule 2 (*The Security Documents*) (together, the "Subordinated Collateral Documents") (together with the UK Security Documents and the Senior Collateral Documents, the "Security Documents"); and
- (D) The Security Agent and BoS (as applicable) have agreed to release the Released Companies from all covenants, mortgages, assignments, charges, guarantees, indemnities, obligations and liabilities of whatsoever nature comprised in the Security Documents on the terms and conditions of this Deed.

**NOW THIS DEED WITNESSETH** as follows:

**1. RELEASE**

- (a) The Security Agent and BoS (as applicable) hereby irrevocably and unconditionally release each of the Released Companies with immediate effect from all covenants, mortgages, assignments, charges, guarantees, indemnities, obligations and liabilities whether past, present or future, incurred or owing, of whatsoever nature comprised in the Security Documents and any other document entered into between the Security Agent and BoS (as applicable) and the Released Companies.
- (b) Without any representation or warranty as to title, the Security Agent and BoS (as applicable) hereby further reassign, retransfer, reconvey and surrender to each of the Released Companies all the property and assets charged or assigned under or pursuant to the Security Documents or any other security, in each case to hold the same freed and discharged from the security created under the Security Documents or any other security and from all rights, claims and demands of the Security Agent and BoS (as applicable) thereunder.

**2. FURTHER ASSURANCE**

The Security Agent and BoS (as applicable) shall, at the request and cost of the Released Companies, execute any deed or document and take any further action reasonably required by the Released Companies to give effect to the release and surrender contained in this Deed.

**3. SEVERABILITY**

The provisions of this Deed are distinct and severable from each other and the invalidity or unenforceability of any provision of this Deed shall not prejudice or affect the validity or enforceability of any such other provision.

**4. COSTS AND EXPENSES**

The Released Companies who have signed this deed shall promptly on demand pay the Security Agent and BoS (as applicable) the amount of all costs and expenses (including legal fees) reasonably incurred by them in connection with the negotiation, preparation, execution and perfection of this Deed.

**5. THIRD PARTY RIGHTS**

A person who is not party to this Deed shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Deed. This clause does not affect any right or remedy of any person which exists or is available otherwise than pursuant to that Act.

**6. COUNTERPARTS**

This Deed may be executed in any number of counterparts and this has the same effect as if the signatures (and seals, if any) on the counterparts were on a single copy of this Deed.

**7. GOVERNING LAW**

This Deed shall be governed by and construed in accordance with English Law.

**IN WITNESS** whereof the parties have executed this Deed as a deed the day and year first above written.
