## CONFIRMATORY ASSIGNMENT OF SERVICE MARK

By WEISLEDER ASSOCIATES, INC., a Florida corporation ("WAI"), in favor of DOMINION ENTERPRISES, a Virginia general partnership ("Dominion"), effective as of the 16<sup>th</sup> day of October, 2007.

Pursuant to an Asset Purchase Agreement executed by the parties on May 31, 2007 (the "Grant Date"), WAI (and other related parties) conveyed its ongoing and existing automotive financing lead-generation business to Dominion, along with all related trademarks and/or service marks that are registered in or the applications for which are pending with the United States Patent and Trademark Office (the "Marks"), all right, title, and interest to which were held by WAI.

The Marks initially conveyed pursuant to the Asset Purchase Agreement inadvertently omitted the service mark described in Exhibit A hereto (the "Additional Mark"). The parties now desire to confirm the conveyance to Dominion of the Additional Mark by this Confirmatory Assignment.

WAI therefore states as follows:

1. WAI hereby confirms that it has assigned to Dominion, its successors and assigns, from and after the Grant Date, its entire right, title and interest in the Additional Mark and its accompanying goodwill, including, without limitation:
  - a. all renewals thereof;
  - b. all proceeds therefrom, including, without limitation, all income, royalties, damages, and payments now and hereafter due and/or payable under and with respect thereto, including (without limitation) damages and payments for past or future infringements thereof;
  - c. the right to sue and recover for past, present, and future infringements thereof; and
  - d. all rights corresponding thereto and throughout the United States.
2. This confirmatory assignment reflected hereunder remains subject to the terms and conditions contained in the Asset Purchase Agreement.
3. This assignment applies to the Additional Mark in the United States and throughout the world.
