Dear Sir or Madam:

This is Primus Telecommunications Group, Incorporated's ("Primus") request for correction of an improperly filed and recorded assignment with respect to Primus' Registration No. 2,048,650 pursuant to TMEP § 503.06(c).

Primus Telecommunications Group, Incorporated, has been and continues to be the owner of Registration No. 2,048,650 since 1999. However, in February, 2002, Telerate, Inc., a party unrelated to and unauthorized by Primus and its predecessor in interest, Telegroup, Inc., improperly recorded an assignment of Registration No. 2,048,650 from Telerate, Inc. to Telerate Holdings, Inc. This erroneously recorded assignment is reflected on Reel/Frame No. 2029/0535.

The correct chain of title should be as follows:

- (1) Telegroup, Inc., the original applicant, assigned the entire interest in Registration No. 2,048,650 to Primus in 1999 (Reel/Frame No. 1936/0875); and
- (2) Primus recorded a security interest in Registration No. 2,048,650 to Lehman Commercial Paper Inc. in 2005 (Reel/Frame No. 3071/0264).

Per TMEP § 503.06(c), Primus respectfully submits that the chain of title for Registration No. 2,048,650 should not be considered altered by the incorrect assignment and that Reel/Frame No. 2029/0535 be deleted from the record of Registration No. 2,048,650 so that Primus Telecommunications Group, Incorporated is reflected as the true and correct owner.

On a final note, Primus contacted the Attorney of Record for Telerate, Inc. and Telerate Holdings, Inc. and requested that he file the appropriate correction documentation for the erroneous assignment recordation. Primus was informed that said correspondent no longer represented Telerate, Inc. and Telerate Holdings, Inc. Moreover, he had no additional information regarding how to contact the party, which he believed may no longer exist. Accordingly, Primus files this corrected cover sheet.
