WHEREAS, KOI Group, Inc., a Nevada corporation (“Assignee”), desires to acquire all of Assignor’s right, title, and interest in and to the Marks and the goodwill associated therewith, and all applications for registrations thereof; and, Assignor desires to assign all of its rights, title, and interest in the foregoing to the Assignee.

NOW, THEREFORE, for payment of the sum of fifty thousand dollars (\$50,000) from Assignor to Assignee, and, other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells and irrevocably transfers unto said Assignee all right, title, and interest in and to the Marks, and any and all derivatives thereof, whether in existence now or in existence in the future, as to all media now in existence or in existence in the future, as to all Classes of goods, together with any and all statutory or common law trademark or trade-dress rights in and to: (a) any application for registration of or Registration in the Marks; (b) the goodwill of the business symbolized by and associated with the Marks and any applications for registration thereof; and (c) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks or any applications for registrations thereof or such associated goodwill. It is further agreed that upon the request of the Assignee, Assignor shall duly execute, acknowledge, and deliver all such further acts, deeds, assignments, transfers, conveyances, powers of attorney, and assurances as may be reasonably required to effect the terms of this Agreement.
