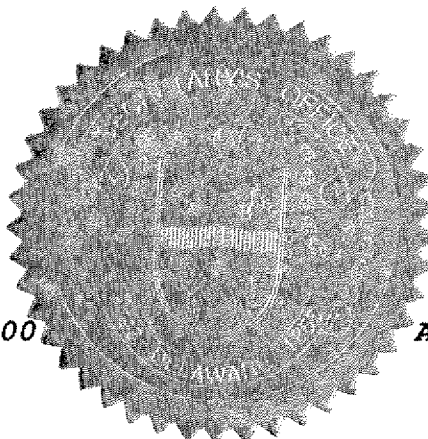

RESOLVED, that the Certificate of Incorporation be amended by replacing Section 1 with the following:
