**UNITED STATES TRADEMARK ASSIGNMENT**  
**NUNC PRO TUNC**

WHEREAS, ROLAND INDUSTRIES, INC., a Missouri corporation having its offices at 501 West First Avenue, Columbus, Ohio 43215 ("Assignor") adopted and used in commerce and was the sole owner of the trademark HERITAGE, Registration Number 1,480,970 and referred to herein as the "Trademark" in the United States Patent and Trademark Office, and the goodwill of the business symbolized by the said Trademark; and

WHEREAS, ABITEC CORPORATION, a Delaware corporation having its offices at 501 West First Avenue, Columbus, Ohio 43215 ("Assignee"), by operation of law, has acquired the entire right, title and interest in and to the Trademark pursuant to the reorganization of Assignor by a merger with and into Assignee, which was the surviving corporation resulting from such reorganization.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns, nunc pro tunc as of [September 14, 1999], all right, title and interest in and to the Trademark, including, without limitation, all common law and statutory rights pertaining thereto and together with the goodwill of the business symbolized by the Trademark.

WHEREAS, Assignor authorizes and requests the United States Commissioner of Patents and Trademark to issue all trademark registrations and renewals which may issue with respect to the Trademark to Assignee, its successors and assigns, in accordance with this Assignment.

WHEREAS, Assignor binds itself, its successors and assigns, to execute to Assignee, its successors and assigns, any further documents or instruments and do any and all further acts that

may be necessary to vest in Assignee, its successors or assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States Patent and Trademark Office.


