BETWEEN:

1. **THE BOC GROUP PLC** whose registered office is at Chertsey Road, Windlesham, Surrey, GU20 6HJ (registered in England with number 00022096);
2. **BOC LIMITED** whose registered office is at Chertsey Road, Windlesham, Surrey, GU20 6HJ (registered in England with number 337663);

(each an "Assignor" and together the "Assignors"); and
3. **EDWARDS LIMITED** whose registered office is at Kirkland & Ellis International LLP, 30 St. Mary Axe, London, EC3A 8AF (registered in England with number 06124750) (the "Assignee").

WHEREAS:

- (A) The Assignors are the proprietors of the trade marks and applicants for registration of the trade mark applications details of which are set out in the Schedule hereto (the "Trade Marks").
- (B) The Assignors have agreed to assign the Trade Marks to the Assignee.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. **Assignment**

In consideration of the payment set out at paragraphs 3.4(D) and 3.6 of Schedule 10 to the agreement relating to the sale and purchase of the Edwards Equipment Division between the Assignors and others and the Assignee and others dated 12 March 2007, each Assignor hereby assigns to the Assignee all its right, title and interest in and to those Trade Marks set out under its name in the Schedule together with all goodwill of the business in relation to which such Trade Marks are used (but no other or greater goodwill), including all rights, privileges and advantages thereto including, without limitation, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereof to hold unto the Assignee absolutely.

2. **Further Assurance**

The Assignors shall, at the request and cost of the Assignee, execute any further documents that may be necessary to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder.

3. **Governing Law**

This Assignment shall be governed by and construed in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English Courts in relation to all matters arising out of this Assignment.






