I, Mark A. Funaki, hereby declare:


1. I am Secretary of Jafra Cosmetics International, Inc., a Delaware corporation.
2. On April 30, 1998, Jafra Cosmetics International, Inc., a California corporation, and CDRJ Acquisition Corporation merged. The name of the surviving corporation was Jafra Cosmetics International, Inc., a Delaware corporation. As a result of the merger, Jafra Cosmetics International, Inc., a Delaware corporation, became the owner of, among others, Application Serial No. 75/340,837 for the mark FM FORCE MAGNETIQUE. Application Serial No. 75/340,837 matured into Registration No. 2,190,871. The exhibit to the merger document that was recorded with the U.S. Patent and Trademark Office contained a typographical error incorrectly listing the serial number for this application as 74/340,837. This merger document was recorded at Reel/Frame No. 1730/0029. As a result of the typographical error, the United States Patent and Trademark Office incorrectly recorded the merger document as to Application Serial No. 74/340,837 rather than Application Serial No. 75/340,837 to Jafra Cosmetics International, Inc., a Delaware corporation.

3. It is requested that the April 30, 1998 recordal as to Application Serial No. 75/340,837/Registration No. 2,190,871 be recorded reflecting Jafra Cosmetics International, Inc., a Delaware corporation, as the prior owner of Application Serial No. 75/340,837/Registration No. 2,190,871 who, then, with full authority as the owner, assigned Registration No. 2,190,871 to Jafra Cosmetics, S.A. de C.V., the present owner. See Reel/Frame No. 2079/0522.

4. To facilitate the recordal of the corrected merger document, and pursuant to TMEP §503.06(b), attached is the original merger document which was submitted to the United States Patent and Trademark Office on May 22, 1998. I have corrected the typographical error so that the correct application serial number for the mark FM FORCE MAGNETIQUE is reflected. I have initialed the correction.

FOURTH: That in accordance with the agreement of merger, the merger shall become effective upon the filing of this certificate with the Delaware Secretary of State.





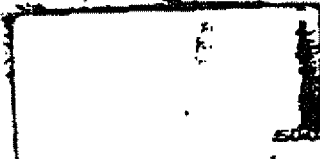
