## MASTER TRADEMARK ASSIGNMENT

This Master Trademark Assignment is made and entered into as of November 8, 2007, (this "Assignment"), by Viacom International Inc. ("Assignor"), in favor of Tempo Networks, LLC, a Delaware limited liability company ("Tempo"). Capitalized terms used but not defined herein have the meanings assigned to them in the Membership Interest Purchase Agreement by and between Assignor and Caribbean Project Acquisition, LLC, a Delaware limited liability company ("Buyer"), dated as of November 8, 2007 (the "Purchase Agreement").

Pursuant to the Purchase Agreement, Assignor has assigned all of its right, title and interest in and to certain trademarks and service marks throughout the world, including all the trademarks, service marks and applications listed on Schedule 1 attached hereto, (the "Trademarks").

The parties wish to execute this Assignment for purposes of transferring the Trademarks pursuant to the Purchase Agreement and recording this Assignment with the U.S. Patent and Trademark Office and all applicable foreign intellectual property offices registrars, as may be necessary to effectuate the assignment and transfer of the Trademarks from Assignor to Tempo.

In consideration of the premises and the mutual representations, warranties, covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Tempo: (a) all of Assignor's right, title and interest in and to the Trademarks; (b) any and all goodwill of any business associated and connected therewith or symbolized thereby; (c) all proceeds therefrom and the right to bring an action at law or in equity for any infringement, dilution or violation of any of the Trademarks occurring prior to the date hereof; and (d) the right to collect all damages, settlements and proceeds relating to the Trademarks.
2. To the extent the Trademarks include any United States trademark application that is based on an intent-to-use, Assignor hereby acknowledges that this Assignment is to a successor to that portion of Assignor's business to which the Trademarks pertain, in accordance with 15 U.S.C. § 1060(a)(1).
3. As further set forth in the Purchase Agreement, Assignor shall, at Buyers' reasonable request, take such further action and execute such additional agreements and instruments as may be necessary to effect the assignment contemplated hereby and to perfect Tempo's title in and to the Trademarks.
4. This Assignment is subject to all the terms and conditions of the Purchase Agreement. The parties intend that this Assignment is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the Agreement, which govern the parties' rights and interests in the Trademarks.


