**RELEASE OF SECURITY AGREEMENT
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of September 25th 2007, is made by U.S. Bank National Association (the "Trustee"), as successor in interest to Firststar Bank, N.A., in favor of Mikohn Gaming Corporation, MGC, Inc., Casino Excitement, Inc., and Progressive Games, Inc. (collectively, "Borrowers") as follows:

WITNESSETH

WHEREAS, pursuant to the Security Agreement dated August 22, 2001 ("Security Interest"), and recorded with The United States Patent and Trademark Office on January 31, 2002 at Reel/Frame No. 2430/0779, the Borrowers granted the Trustee, a security interest in its trademarks and all applications and registrations therefore, including goodwill (the "Trademark Collateral");

The Trustee agrees to provide the Borrowers with any information and additional authorization necessary to effect the release of the Trustee's security interest in the Released Trademark Collateral.
