The voting group consisting of 8,050,453 outstanding shares of Common [class or series] stock is entitled to 8,050,453 votes. There were 5,224,118 votes present at the meeting. The voting group cast 5,224,118 votes for and - 0 - votes against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.


