**ASSIGNMENT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS AND PATENTS**

THIS ASSIGNMENT OF SECURITY INTEREST is made to further secure the satisfactory performance and payment of all the obligations of the Assignors (the "Secured Obligations") under the Revolving Credit, Term Loan and Security Agreement between the Assignors and the Assignee, dated as of September 17, 2007 (as amended from time to time, the "Credit and Security Agreement"). Upon the satisfaction of all such Secured Obligations, the Assignee shall execute, acknowledge, and deliver to the Assignors an instrument in writing releasing the security interest in the Marks and Patents acquired under this Assignment of Security Interest. This Assignment of Security Interest is in addition to any and all previous security interests or assignments granted by Assignors to Assignee and/or filed by Assignee with the United States Patent and Trademark Office.

This Assignment of Security Interest has been granted in conjunction with the security interest granted to the Assignee under the Credit and Security Agreement. The right and remedies of the Assignee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Credit and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment of Security Interest are deemed to conflict with the Credit and Security Agreement, the provisions of the Credit and Security Agreement shall govern.
