ASSIGNMENT OF TRADEMARKS

ASSIGNORS hereby transfer to ASSIGNEE the entire right, title and interest of the ASSIGNORS in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS and Registration Nos. 2,509,664 and 2,593,959; and




