ASSIGNMENT

WHEREAS, Coburn Corporation, a New Jersey corporation (hereinafter referred to as "ASSIGNOR"), is the record owner of the trademarks listed on Schedule A hereto, (hereinafter collectively the "TRADEMARKS"), and

WHEREAS, Coburn Graphic Films, Inc. a New Jersey corporation (hereinafter referred to as "ASSIGNEE"), in connection with a Purchase Agreement dated as of August 14, 2000 among Assignor, Assignee and the stockholders of Assignor (the "Asset Purchase Agreement") is acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARKS, together with the goodwill of the business associated with the TRADEMARKS:

NOW, THEREFORE, in consideration of the amounts set forth in the Purchase Agreement and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR hereby transfers and assigns to ASSIGNEE its entire right, title and interest in and to the TRADEMARKS, together with the goodwill of the business associated with said TRADEMARKS; and

ASSIGNOR, does also hereby sell, assign, transfer and set over, onto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks as the property of ASSIGNEE; and

ASSIGNOR, hereby covenants that it has full right to convey its entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.
