**TRADEMARK ASSIGNMENT**

(Servicemark Registered Under Registration No. 3,097,898, Serial Number 78-641,147)

THIS TRADEMARK ASSIGNMENT AGREEMENT is made by and between AMERICANA DE SERVICIOS OF MIAMI, INC., a Florida corporation ("Assignor") and Intermex Wire Transfer, LLC, a Florida limited liability company ("Assignee").

WHEREAS, Assignee desires to acquire from Assignor any common law right, title and interest Assignor has or may have in and to the Servicemark as well as all right, title and interest Assignor has in and to the Registration.

NOW THEREFORE, in consideration for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest it has or may have in and to the Servicemark and the Registration together with the good will of the business symbolized by the Servicemark and the Registration and with which the Servicemark and the Registration are associated, with the right to recover for damages and profits and all other remedies for past infringement thereof.

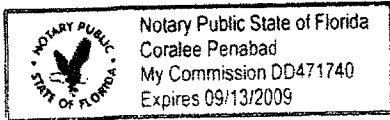
