Pursuant to the provisions of Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Global Beverage Group Ltd., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Botler Systems, Inc., a North Carolina corporation.
